(57) Abstract:

(EN): The invention relates to an ear protection plug (10) that consists of a sound insulating inset (12) and a handling component (14, 16, 18) that is connected thereto. The sound insulating inset can be inserted into the acoustic meatus of the ear by means of said handling component which is provided with a carrier element that is visible outside the ear.

(FR): L'invention concerne un bouchon de protection auditive (10) composé d'un insert de protection sonore (12) et d'une partie de maniement (14, 16, 18) reliée à cet insert, l'insert de protection sonore pouvant être introduit dans le conduit auditif de l'oreille au moyen de la partie de maniement.
