**(57) Abstract:**

**(EN):** The invention relates to a clamp (1) for fastening and connecting tubes (2,3), especially for fastening a connecting tube to a heat exchanger in a motor vehicle. At least one terminal area (8) of the inventive clamp (1) is bent back.
