(54) Title (FR): PROCEDE DE NETTOYAGE A SEC

(57) Abstract:

(EN): A dry cleaning process for in-home dry cleaning comprising a dry cleaning step of contacting a laundry article with a dry cleaning composition whereby the liquor to cloth ratio (w/w) (LCR) is at most 20, and said composition comprises a non-flammable, non-chlorine containing organic dry cleaning solvent and surfactant, whereby the surfactant to cloth ratio (w/w) is at most 0.12.

(FR): L'invention concerne un procédé de nettoyage à sec destiné au nettoyage à sec domestique, qui comprend une étape consistant à mettre en contact un vêtement avec une composition de nettoyage à sec.
