(57) Abstract:

(EN): Disclosed is a method for collecting an object material from a solution which comprises a step wherein a second solvent is added and mixed into a solution composed of the object material to be collected and a first solvent so as to form an emulsion of the second solvent wherein the object material is contained in a non-uniformly dispersed state, and a step wherein the thus-obtained emulsion is separated from the solution.
