**(57) Abstract:**

**(EN):** A mold powder for continuous casting of steel is characterized by comprising, as a carbonaceous material, not more than 0.5 (including zero) mass% of carbon black, 0.5-20 mass% of a carbon powder other than carbon black, and 0.1-7.0 mass% of a carbohydrate powder.

**(FR):** Une poudre de lingotière pour coulée continue d'acier est caractérisée en ce qu'elle comprend, comme matériau carboné, 0,5 % en masse maximum (y compris zéro) de noir de carbone, entre 0,5 et 20 % en masse de poudre de carbone autre que le noir de carbone, et entre 0,1 et 7,0 % en masse de poudre de carbohydrates.

**(JA):** 本発明の鋼の連続鑄造用粉末状モールドパウダーは、炭素質原料としてカーボンブラックを0.5質量%以下(ゼロを含む)、カーボンブラック以外の炭素粉を0.5~20質量%、及び炭水化物粉を0.1~7.0質量%含有することを特徴とする。
