**(57) Abstract:**

**(EN):** The invention relates to an osteosynthesis plate (1b) comprising at least two adjacent bores (4, 4'). According to the invention, a notch (5b) is disposed between the at least two adjacent bores on the convex face (6) of the osteosynthesis plate.

**(FR):** La présente invention concerne une plaque d'ostéosynthèse (1b) comprenant au moins deux orifices (4, 4') adjacents. Selon l'invention, une entaille (5b) est placée entre les deux ou plus orifices sur la face convexe (6).
