(57) Abstract:

(EN): [PROBLEMS] To provide a medicament transpiration sheet that excels in medicament transpiration effect, realizing a facilitation of inhalation. [MEANS FOR SOLVING PROBLEMS] There is provided medicament transpiration sheet (1) comprising hydrous gel layer (2) containing a medicament, wherein the hydrous gel layer (2) has on its one side flat and smooth sticking surface (3) and on the opposite side exposure surface (5) whose surface area is greater than that of the sticking surface (3).

(FR): La présente invention a pour objet une lingette pour transporisation de médicament (1) présentant un excellent effet transporisant, ce qui résulte en une inhalation facilitée. Ladite lingette (1) comprend une couche d'hydrogel (2) contenant un médicament. L'une des faces de ladite couche (2) présente une surface adhérente plate et lisse (3), tandis que l'autre face est destinée à être en contact avec l'extérieur (5) et présente une surface totale plus importante que celle de la surface adhérente (3).
