(57) Abstract:

(EN): A pressed agglomerate (compacted material) which is suitable for consumption, a process for its preparation, its use for aromatizing products and products comprising such a pressed agglomerate are described. The pressed agglomerate comprises cold water swellable starch and flavor, optionally maltodextrin and color.
