**(57) Abstract:**

**(EN):** The invention relates to a device (1) for actuating a clutch, in particular a clutch in the drivetrain of a motor vehicle, between a drive motor and a shift transmission. Said device comprises a pneumatic or hydraulic piston / cylinder arrangement (21,9,10) which in a floating fashion relative to a transmitting means (2) is operatively connected to a release bearing (3).

**(FR):** L'invention concerne un dispositif (1) pour actionner un embrayage, notamment un embrayage dans la chaîne de transmission d'un véhicule automobile entre un moteur d'entraînement et une boîte de vitesses. Ce dispositif comprend un agencement cylindre/piston pneumatique ou hydraulique (21, 9, 10) qui est monté volant par rapport à un moyen de transfert (2) en liaison coopérante avec un palier de débrayage (3).
