**(57) Abstract:**

**(EN):** A method of remotely presenting and selling visual media to a customer comprises steps of participating in a remote oral communication session with the customer and altering at least a portion of what the customer is able to view on a visual display device during the oral communication session. The visual media preferably comprises images of persons or pets that are familiar to the customer.
