(57) Abstract:

(EN): Disclosed is a curable composition which exhibits good curability by using a non-organotin catalyst. Specifically disclosed is a curable composition containing an organic polymer (A) having a silicon-containing group which can be crosslinked by forming a siloxane bond, a fluoride salt compound (B) and one or more fillers (C) selected from the group consisting of a precipitated calcium carbonate surface-treated with a substance other than fatty acids, a heavy calcium carbonate and a silica. Also disclosed is a catalyst composition.

(FR): L'invention concerne une composition durcissable qui présente une bonne aptitude au durcissement utilisant un catalyseur non organostannique. L'invention concerne de manière spécifique une composition durcissable contenant un polymère organique (A) possédant un groupe contenant du silicium qui peut être réticulé en formant une liaison siloxane, un composé de sel de fluor (B) et une ou plusieurs charge(s) (C) choisies parmi le groupe constitué d'un carbonate de calcium précipité traité en surface à l'aide d'une substance autre que des acides gras, un carbonate de calcium lourd et une silice. L'invention concerne également une composition de catalyseur.

(JA): 本発明が解決しようとする課題は、非有機錫触媒を用いて、良好な硬化性を有する硬化性組成物を提供することであり、シロキサン結合を形成することにより架橋し得るケイ素含有基を有する有機重合体(A)と、フッ化塩化合物(B)と、脂肪酸以外で表面処理された沈降炭酸カルシウム、重質炭酸カルシウム、シリカから選択される1種以上の充填剤(C)と、を含有する硬化性組成物によって上記課題を解決するとともに、併せて触媒組成物を提供するものである。
