(57) Abstract:

(EN): An arrangement for the support and radial-axial sealing between a housing and a mobile element is disclosed. Separate components, which are installed in a row for support and sealing, are provided for the support and for radial-axial sealing. At least one radial-axial seal is provided between at least two bearings.

(FR): L'invention concerne un agencement destiné à assurer le support et l'étanchéité radiale/axiale entre un carter et un élément mobile. Le support et l'étanchéité radiale/axiale sont assurés au moyen d'éléments séparés respectifs qui sont montés en série à des fins de support et d'étanchéité, au moins un élément d'étanchéité radiale/axiale étant disposé entre au moins deux éléments de support.
