**(57) Abstract:**

**(EN):** A method for guaranteeing a price of an itinerary is disclosed herein. The method comprises receiving travel attributes from a customer. Based on the travel attributes, one or more itineraries can be generated. The itineraries can be provided to the customer along with options to lock the price of the itineraries for a predetermined time in consideration of a payment. The payment for locking the price for a selected itinerary may be received from the customer. Upon making the payment, the customer may be able to purchase the itinerary at the price within the predetermined time.

**(FR):** L'invention concerne une méthode de garantie du prix d'un itinéraire. La méthode consiste à recevoir des attributs de voyage d'un client. En fonction des attributs de voyage, on peut produire un ou plusieurs itinéraires. Les itinéraires peuvent être fournis au client en même temps que des options de verrouillage du prix des itinéraires pour une durée prédéterminée moyennant un paiement. Le paiement pour le verrouillage du prix pour un itinéraire sélectionné peut être reçu du client. Après la réalisation du paiement, le client peut avoir la possibilité d'acheter l'itinéraire au prix pendant la durée prédéterminée.
