**(57) Abstract:**

**(EN):** The invention relates to the field of aqueous surfactants having a pearlescent effect and more particularly to the use of specific esters of tetrahydrofuran glycol as a pearlescent wax that has a very high degree of brilliance and high whiteness, as well as to pearlescent concentrates which comprise said esters and are used especially in cosmetics.

**(FR):** La présente invention se situe dans le domaine des agents tensioactifs aqueux à effet perlescent et concerne l'utilisation d'esters spéciaux du tétrahydrofurane glycol en tant que cire perlescente à très bonne brillance et à haut degré de blanc, ainsi que des concentrés perlescents contenant ces esters, utilisés en particulier dans des produits cosmétiques.
