(57) Abstract:

(EN): The invention relates to a configurational stereoisomer, referred to as enantiomer E₃, of bromadiolone, having, as determined by the chromatographic analysis of a bromadiolone composition comprising four configurational stereoisomers of bromadiolone, carried out under conditions described hereinafter, a retention time t₃ with a value such that t₁ < t₂ < t₃ < t₄; t₁, t₂ and t₄ representing the retention times of the configurational stereoisomers of bromadiolone different from said enantiomer E₃, said analysis being carried out at a temperature of 27.3°C.
