**(57) Abstract:**

**(EN):** A quarter window assembly (10) for a soft top cover assembly that is removable. The quarter window assembly (10) is connectable to the soft cover assembly. The quarter window assembly (10) has a hard corner assembly (16) mountable to features connected to a vehicle. The hard corner assembly (16) is an injection molded plastic assembly. The quarter window assembly (10) also has a panel (12) carrying at least one window (14), and the panel (12) is secured to the hard corner assembly (16).

**(FR):** L'invention porte sur un ensemble vitre de fenetre arriere (10) pour un ensemble capote souple qui est amovible. L'ensemble vitre de fenetre arriere (10) peut être relié à l'ensemble capote souple. L'ensemble vitre de fenetre arriere (10) comporte un ensemble coin dur (16) pouvant être monté sur des caractéristiques reliées à un véhicule. L'ensemble coin dur (16) est un ensemble en plastique moulé par injection.
