(57) Abstract:

(EN): A synergistic antimicrobial composition containing 3-iodo-2-propynyl-butylocarbamate and diamine is provided. Also, a coating, a method of inhibiting the growth of or controlling the growth of microorganisms in an aqueous media, and a dry film containing 3-iodo-2-propynyl-butylocarbamate and diamine are further provided.
