(57) Abstract:

(EN): An apparatus is configured to be employed within a base station. The apparatus comprises baseband circuitry which includes a radio frequency (RF) interface and one or more processors. The one or more processors are configured determine repetition level (RL) thresholds, allocate downlink resources, wherein the downlink resources include a repetition level (RL), send downlink data to the RF interface for transmission to a user equipment (UE) according to the RL, receive repetition feedback from the RF interface based on the transmission to the UE, and update the downlink resources based on the repetition feedback.
