(57) Abstract:

(EN): The disclosure is related to compositions having water permeability greater than about 20 g/(hr*m²) that includes one or more elastomers and one or more agents and methods of preparing the same. The compositions are suitable for use in acoustical devices such as earpieces, e.g., in-ear earpieces.
