(57) Abstract:

(EN): An exfoliant which acts only on dead skin cells, by dissolving hyperkeratoses, does not harm the skin or cause discomfort, dispensing with the use of cutting tools, and which is also capable of effectively treating, by the same principle, onychophoses and onychomycoses.

(FR): L'invention concerne un exfoliant agissant uniquement sur les cellules mortes de la peau, par dissolution des hyperkératoses, sans agresser la peau ni occasionner de gêne, l'utilisation d'instruments coupants n'étant ainsi plus nécessaire, les onychophoses et onychomycoses pouvant en outre être traitées efficacement selon le même principe.
