**(57) Abstract:**

**(EN):** A jaw support (10) comprising a chest engaging member (15) provided to rest on an upper area of the chest of a user below the jaw, a jaw support member (14) connected to the chest engaging member (16) and a neck support (18) extending around a rear side of the neck of the user. The chest engaging member (16) and the jaw support member (14) comprise U-shaped first and second elongate members (20, 30) respectively. The jaw support member (14) is pivotable between a first position, in which it is adjacent the chest engaging portion (16), and a second position, in which it moves away from the chest engaging member (16) to support the chin. The first and second elongate members (20, 30) each comprise flat elongate members having corresponding shapes.

**(FR):** L'invention porte sur un support de mâchoire (10) comprenant un élément de mise en prise de poitrine (15) utilisé pour reposer sur une zone supérieure de la poitrine d'un utilisateur sous la mâchoire, un élément de support de mâchoire (14) relié à l'élément de mise en prise de poitrine (16) et un support de cou (18) s'étendant autour d'un côté arrière du cou de l'utilisateur. L'élément de mise en prise de poitrine (16) et l'élément de support de mâchoire (14) comprennent respectivement des premier et second éléments allongés en forme de U (20, 30). L'élément de support de mâchoire (14) peut pivoter entre une première position, dans laquelle il est adjacent à la partie de mise en prise de poitrine (16), et une seconde position, dans laquelle il s'éloigne de l'élément de mise en prise de poitrine (16) pour soutenir le menton. Les premier et second éléments allongés (20, 30) comprennent chacun des éléments allongés plats ayant des formes correspondantes.
