(57) Abstract:

(EN): Cart or workstation built into a case and designed for use in a surgery unit and/or for teaching, with a computer, screens and infrared or other camera for reading and medical diagnosis, comprising a workstation (5) built into a case (1) with wheels and a brake (2), door and ventilation (3), internal lighting (4), server and peripherals, operator monitor with articulated arm (6), surgeon's monitor (7) on a movable pedestal (8), free retractable boom (9), infrared camera (12) and ordinary camera (14).
