(57) Abstract:

(EN): The present invention relates to method of manufacturing a sleeve for a beverage holder, the method comprising: providing a flexible material; shaping the flexible material into an at least substantially rectangular shape with a first end and a second end opposite the first end; providing one or more connecting members; connecting the first end and the second end together using the one or more connecting members so that the flexible material surrounds the beverage holder.
