(57) Abstract:

(EN): The invention relates to a synergistic composition of naturally occurring substances, which is particularly effective in the treatment and prevention of gastric or gastroesophageal diseases. The composition of the invention comprises the synergistic combination of at least one antacid, an extract from a fruit of a plant of the genus *Musa*, and at least one protease digestive enzyme. The synergistic composition of the present invention may be provided in the form of a pharmaceutical composition or a food supplement, or in the form of a kit-of-parts.
