(57) Abstract:

(EN): Permeable sheets attached to tanks and or tank apparatus A method of retaining solids in a tank system comprising the steps of: a) using a permeable copolymer nodule sheet 11 as a partition for retaining solids 29 from a suspension of the solids in a liquid; b) sealedly attaching said permeable copolymer nodule sheet 11 where any of its sides 13 make contact with the surface of said tank system 19.
