(57) Abstract:

(EN): A ophthalmic emulsion for ocular delivery of antioxidants comprising one or more antioxidants, at least one oil of vegetable, mineral or animal origin, at least one surfactant and at least one pharmaceutically acceptable excipient, wherein the pH is in the range of about 4 to 8.
