(57) Abstract:

(EN): A seed fulfillment system is an automated system for sorting and delivering different types of seeds from different seed containers to a shipping-container loading system which loads shipping containers with the seeds. The seed fulfillment system includes an intermediary-container handling system which conveys intermediary containers of seeds from a filling system to a shipping-container loading system.
