(57) Abstract:

(EN): This system for securing a motor vehicle busbar comprises a busbar (1), an electrically insulating cap (4) for protecting the busbar (1), at least partially covering said bar(1) and at least one fixing screw (5), comprising a body (6) and a screw (5) head (7), for joining together said bar (1) and said protective cap (4), the busbar (1) and the protective cap (4) having an orifice for the passage respectively of the screw (5) body (6) and of the screw (5) head (7), the width of the orifice in the protective cap (4) being at most equal to the diameter of the screw (5) head (7). The invention also relates to a motor vehicle comprising this busbar fixing system.

(FR): Ce système de fixation d'une barre omnibus d'un véhicule automobile, comporte une barre omnibus (1), un capot (4) électriquement isolant de protection de la barre omnibus (1) recouvrant au moins partiellement ladite barre (1) et au moins une vis de fixation (5), comportant un corps (6) et une tête (7) de vis (5), pour la fixation entre ladite barre (1) et ledit capot de protection (4), la barre omnibus (1) et le capot de protection (4) présentant un orifice pour le passage respectivement du corps (6) de vis (5) et de la tête (7) de vis (5), la largeur de l'orifice du capot de protection (4) étant au plus égale au diamètre de la tête (7) de vis (5). L'invention concerne également un véhicule automobile comportant ce système de fixation d'une barre omnibus.
