(57) Abstract:

(EN): A web processing system 102 comprises a first cylinder 24 and a second cylinder 34 that are configured so as to rotate in the same phase while being in contact with a web 4 continuously present along a movement route, and a dancer system 40 for suppressing tension variation in the web 4 between the first cylinder 24 and the second cylinder 34.

(FR): L'invention concerne un système de traitement de bande (102), comprenant un premier cylindre (24) et un second cylindre (34), qui sont conçus de façon à tourner dans la même phase tout en étant en contact avec une bande (4) présente en continu le long d'un itinéraire de déplacement, et un système compensateur (40) destiné à supprimer une variation de tension dans la bande (4) entre le premier cylindre (24) et le second cylindre (34).
