**(57) Abstract:**

**(EN):** An object sorting system and method, the system comprising: An object providing device, in a first region, providing objects to be sorted, a mobile transport device, in a second region, transporting the objects to be sorted, and an object receiving device, in a third region, receiving the objects to be sorted, the second region and the third region being distributed in sequence without overlapping. The system saves system construction costs as well as improves the conveyor efficiency of the object sorting system.

**(FR):** L'invention porte sur un système et un procédé de tri d'objets, le système comprenant : dans une première région, un dispositif de fourniture d'objets fournissant des objets à trier, dans une deuxième région, un dispositif de transport mobile transportant les objets à trier, et, dans une troisième région, un dispositif de réception d'objets recevant les objets à trier, la deuxième et la troisième région étant réparties dans cet ordre sans se chevaucher. Le système de tri d'objets a des coûts de construction plus faibles et une plus grande efficacité de transport.

**(ZH):** 一种物品分拣系统及方法,该系统包括:在第一区域提供待分拣物品的供件端,在第二区域内运送待分拣物品的移动运输装置,以及在第三区域内接收待分拣物品的物品接收装置,所述第二区域及所述第三区域依序不重叠分布。通过该系统,在节省系统建设成本的同时,提高了物品分拣系统的传送效率。
