(57) Abstract:

(EN): Disclosed in the present application is an information operating method and device, and a medium. The method comprises: receiving an operation rule of a current account to other accounts in advance; and for each of the other accounts, when receiving information published by said other account, performing an operation on the information according to the operation rule. The present invention is used to solve the problem of affecting the user experience caused by frequent operations on information published by other accounts when a user uses a social application.
