**(57) Abstract:**

**(EN):** The disclosure provides for a display apparatus for a vehicle. The display apparatus includes a display screen configured to emit images in an emission direction; a mirror apparatus configured to reflect the images from the display screen towards a viewing direction; and a lens apparatus configured to receive the images from the mirror, wherein the lens apparatus is configured to project the images to a focal distance substantially opposite the viewing direction, wherein the focal distance is positioned at least about 750 mm from eyes of the driver.

**(FR):** L'invention concerne un appareil d'affichage pour un véhicule. L'appareil d'affichage comprend un écran d'affichage configuré pour émettre des images dans une direction d'émission ; un appareil de rétroviseur configuré pour réfléchir les images de l'écran d'affichage vers une direction de visualisation ; et un appareil de lentille configuré pour recevoir les images provenant du rétroviseur, l'appareil à lentille étant configuré pour projeter les images à une distance focale sensiblement opposée à la direction de visualisation, la distance focale étant positionnée à au moins environ 750 mm des yeux du conducteur.
