(57) Abstract:

(EN): Examples disclosed herein provide a computing device. One example computing device includes a display member and a base member rotatably connected to each other via a hinge. The computing device includes a retractable foot to extend from a bottom surface of the base member when the display member is to be rotated open from a closed position to a first operating position.
