(57) Abstract:

(EN): A method and system for providing cold transportation is disclosed. A method includes receiving a registration of a transportation provider on a digital marketplace. A method further includes verifying capabilities of the transportation provider and receiving a transportation request from a requestor. A method further includes making the transportation request available to multiple transportation providers. A method further includes receiving a claim request from a transportation provider, wherein the claim indicates a desire to fulfill the transportation request. A method further includes arranging for payment of the transportation request between the transportation provider and the requestor. The method is embodied in a digital marketplace.
