**(57) Abstract:**

**(EN):** The invention relates to a vehicle component comprising a colored, translucent plastic component (10, 10A, 10B, 10C, 10D) having a front side and a back side and a metallic layer (20) which is arranged on the back side of the plastic component (10, 10A, 10B, 10C, 10D). The invention also relates to a method for producing the vehicle component.

**(FR):** L'invention concerne un élément structural de véhicule, comprenant un élément structural plastique (10, 10A, 10B, 10C, 10D) translucide et en couleur, pourvu d'une face avant et d'une face arrière, et une couche métallique (20) qui est disposée sur la face arrière de l'élément structural plastique (10, 10A, 10B, 10C, 10D). L'invention concerne par ailleurs un procédé de fabrication de l'élément structural de véhicule.
