(57) Abstract:

(EN): The invention relates to a method for determining properties of agricultural spreading material, comprising the steps of: collecting spreading material by means of one or more collecting devices (10a-10c), wherein the spreading material to be collected is ejected from an agricultural spreader, determining the distribution of the spreading material collected by the one or more collecting devices (10a-10c) by means of image evaluation, and determining properties of individual grains of the spreading material by means of image evaluation.
