**(57) Abstract:**

**(EN):** The present invention relates to cosmetic skin care compositions which comprise a hyperbranched copolymer of the monomers dodecanyl succinic acid anhydride, diisopropanol amine and bis-dimethylaminopropyl amine having quaternary terminal groups and an anionic emulsifier. The copolymer is used in a cosmetic composition comprising the anionic emulsifier for reducing the material transfer to a contacted surface. Preferably the copolymer is polyquaternium-110.

**(FR):** La présente invention concerne des compositions de soin cosmétique pour la peau qui comprennent un copolymère hyperramifié des monomères d'anhydride dodécanyl succinique, d'amine de diisopropanol et de bis-diméthylamino-propylamine comprenant des groupes terminaux quaternaires et un émulsifiant anionique. Le copolymère est utilisé dans une composition cosmétique comprenant l'émulsifiant anionique pour réduire le transfert de matière vers une surface en contact. De préférence, le copolymère se présente sous la forme de polyquaternium-110.
