(EN): This antibacterial twisted yarn is characterized by being provided with: long fibers (11) which are made from normal fibers or piezoelectric fibers that with external energy generate a charge, and short fibers/long fibers (12) which are made from piezoelectric fibers in the case that the long fibers (11) are made from normal fibers, and are made from piezoelectric fibers or normal fibers in the case that the long fibers (11) are made from piezoelectric fibers.
