**(57) Abstract:**

**(EN):** A healthcare capsule having an auxiliary protection function against radiation hazards, formed by mixing a Ganoderma lucidum extract, cell wall-broken ganoderma lucidum spore powder, a Lycium barbarum fruit, a Hericium erinaceus extract, a Lentinula edodes extract, and a Tremella fuciformis extract.
