(57) Abstract:

(EN): This gas turbine combustor is provided with: a flange part which is attached to a casing; an annular extension part which extends from the flange part along the axial direction of the combustor; a pipe which has a first end connected to the flange part and a second end connected to an outer circumferential surface of the extension part and which extends from the first end to the second end on the radially outer side of the extension part; and at least one fuel nozzle that is configured to receive fuel supplied through the pipe and a passageway disposed within the extension part.
