**(57) Abstract:**

**(EN):** Various configurations of picking and packaging carts are disclosed that can be advantageously employed in Ecommerce and retail settings to improve operational efficiency. Examples can preclude the need for a detour from the item retrieval location to a packaging area, prior to delivery to a shipping area, such as a drop-off point. Some examples include a frame; a shelf rack; accessory support units including a printer holder; multiple shipping container support units configured to hold a plurality of shipping containers of a plurality of sizes; and a packaging shelf arrangement comprising a top shelf providing a flat packaging surface.

**(FR):** L'invention concerne diverses configurations de chariots de saisie et d'emballage qui peuvent être avantageusement utilisées dans des établissements de commerce électronique et de vente au détail pour améliorer l'efficacité opérationnelle. Des exemples peuvent éviter d'avoir à faire un détour depuis l'emplacement de récupération d'article vers une zone d'emballage, avant la livraison à une zone d'expédition, telle qu'un point d'abandon. Certains exemples comprennent un châssis ; un support d'étagère ; des unités de support d'accessoire comprenant un support d'imprimante ; de multiples unités de support de contenants d'expédition conçues pour contenir une pluralité de contenants d'expédition d'une pluralité de tailles ; et un agencement d'étagère d'emballage comprenant une étagère supérieure fournissant une surface d'emballage plate.
