(57) Abstract:

(EN): This absorbent article 100 is provided with an absorbent body 10. The absorbent body 10 contains water-absorbent resin particles 10a, the water-absorbent resin particles 10a have a packed bulk density of 0.500 g/cm^3 or more, and the amount of change in the packed bulk density when moisture is absorbed for one hour at a temperature of 30°C and a relative humidity of 80% is 0.020 g/cm^3 or more.

(FR): Selon l'invention, un article absorbant (100) de l'invention est équipé d'un corps absorbant (10). Le corps absorbant (10) comprend des particules de résine absorbantes (10a). Dans les particules de résine absorbantes (10a), la densité apparente compactée est supérieure ou égale à $\#\#\#\#\#\#\#\#$, et la quantité de variation de la densité apparente compactée après absorption de l'humidité pendant une heure à une température de 30°C et une humidité relative de 80%, est supérieure ou égale à $\#\#\#\#\#\#\#\#$.

(JA): 吸収性物品 100 は、吸収体 10 を備え、吸収体 10 は、吸水性樹脂粒子 10a を含有し、吸水性樹脂粒子 10a において、固めかさ密度が 0.500 g/cm^3 以上であり、温度 30°C 、相対湿度 80% で 1 時間吸湿させたときの固めかさ密度の変化量が 0.020 g/cm^3 以上である。
