(57) Abstract:

(EN): A multicopter helicopter comprising one main rotor and two or more secondary rotors operatively connected to a frame is provided, wherein each of the secondary rotors are smaller in diameter than the main rotor, and wherein each secondary rotor is pivotably connected to the frame. A method of manufacturing the multicopter helicopter of the present invention is also provided.
