(57) Abstract:

(EN): This optical film set has a first optical film which is provided with a first adhesive layer and which is disposed on the visible side of an optical element via the first adhesive layer, and a second optical film which is provided with a second adhesive layer and which is disposed on the back surface side of the optical element via the second adhesive layer, a first glass film having a thickness of 50 μm to 150 μm being provided on the visible-side surface of the first optical film, and the thickness of the second adhesive layer being 50 μm to 200 μm .

(FR): L'invention concerne un ensemble de films optiques comprenant un premier film optique qui est pourvu d'une première couche adhésive et qui est disposé sur le côté visible d'un élément optique par l'intermédiaire de la première couche adhésive, et un second film optique qui est pourvu d'une seconde couche adhésive et qui est disposé sur le côté de surface arrière de l'élément optique par l'intermédiaire de la seconde couche adhésive, un premier film de verre ayant une épaisseur de 50 μm à 150 μm étant disposé sur la surface côté visible du premier film optique, et l'épaisseur de la seconde couche adhésive étant de 50 μm à 200 μm .

(JA): 本光学フィルムセットは、第1の粘着剤層を備え、前記第1の粘着剤層を介して光学素子の視認側に配置される第1の光学フィルムと、第2の粘着剤層を備え、前記第2の粘着剤層を介して前記光学素子の背面側に配置される第2の光学フィルムと、を有し、前記第1の光学フィルムの前記視認側の表面に、厚みが50 μm 以上150 μm 以下の第1のガラスフィルムが設けられ、前記第2の粘着剤層の厚みが50 μm 以上200 μm 以下である。
