**(57) Abstract:**

**(EN):** A plant cultivation medium according to the present invention comprises: a bag; and a crushed material which is packed in the bag in a compressed state and is obtained by crushing a foamed body made of an aliphatic polyester-based resin, wherein the ratio of the bulk density of the crushed material after being packed in the bag to the bulk density of the crushed material before being packed in the bag is 1-2 (exclusive of 1).

**(FR):** Un milieu de culture de plante selon la présente invention comprend : un sac; et un matériau broyé qui est ensaché dans le sac dans un état comprimé et est obtenu par broyage d'un corps en mousse constitué d'une résine à base de polyester aliphatique, le rapport de la densité apparente du matériau broyé après avoir été ensaché dans le sac sur la densité apparente du matériau broyé avant d'être ensaché dans le sac étant de 1-2 (à l'exclusion de 1).

**(JA):** 本発明の植物栽培用培地は、袋体と、前記袋体に圧縮された状態で充填され、脂肪族ポリエステル系樹脂からなる発泡体を破碎してなる破碎物とからなり、前記袋体に充填される前の前記破碎物のかさ密度に対する、前記袋体に充填された後の前記破碎物のかさ密度に対する比は、1より大きく2以下である。
