(57) Abstract:

(EN): Disclosed is a communication terminal. The communication terminal comprises: an upper flip cover and a lower flip cover, which are rotatably connected, wherein a system mainboard is arranged on the lower flip cover, a metal plate is arranged on the upper flip cover, and the system mainboard is connected to the metal plate. The communication terminal of the present application can improve the low frequency performance of a communication terminal without expanding a system mainboard.

Le terminal de communication comporte: un couvercle rabattable supérieur et un couvercle rabattable inférieur, qui sont liés de manière pivotante, une carte mère de système étant disposée sur le couvercle rabattable inférieur, une plaque métallique étant disposée sur le couvercle rabattable supérieur, et la carte mère de système étant reliée à la plaque métallique.
