



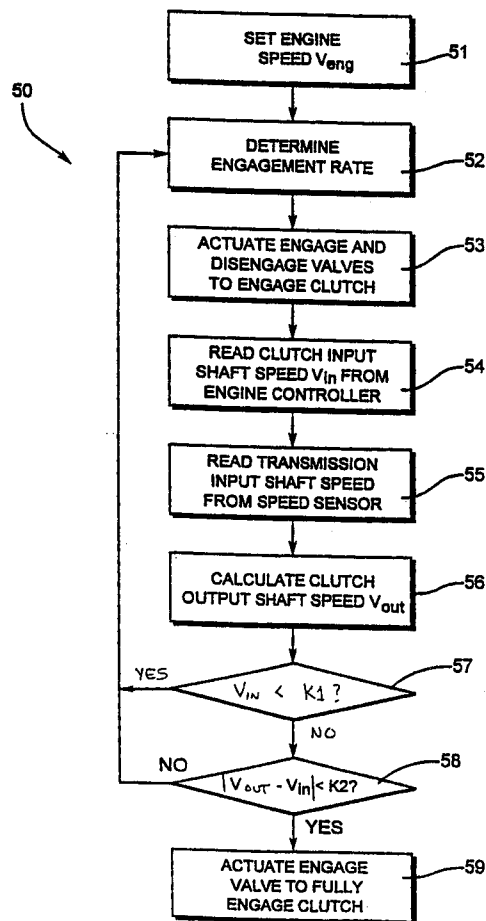

(54) Title: METHOD AND APPARATUS FOR OPERATING A CLUTCH IN AN AUTOMATED MECHANICAL TRANSMISSION

(57) Abstract

A controller (20) sets an engine speed (51), determine engagement rate (52), actuates engage/disengage valve (53), read clutch input speed (54) and transmission input shaft speed (55), calculate clutch output speed (56) and engage clutch as a function of speed difference (57, 58, 59).
