Claims 1-16

Based on the descriptions in documents 1 and 2 cited in the international search report, the inventions of claims 1-16 lack an inventive step.

Document 1 describes cloning of the phytochrome C gene of rice. Document 2 states that phytochrome is involved in the flowering of rice, and the phytochrome C gene is involved in the photoperiod reaction of sorghum, which is also a monocotyledon.

Based on the description in document 2, persons skilled in the art can easily conceive of trying to regulate the flowering of rice by regulating the expression of the phytochrome C gene of rice described in document 1.
