2. The present application does not meet the requirements of PCT Article 33(1) because the subject matter of claim 1 is not novel (PCT Article 33(2)).

D1 discloses (cf. D1) a valve (10) arranged in a fuel-conveying (**gaseous fuel**) line of a motor vehicle, the valve having a valve body (12) and a valve seat (20). The valve body (12) is kept at a distance from the valve seat (20) at least when fuel is flowing through the line. The valve body (12) has

a conical section (32) that faces the valve seat (20) and thin walls relative to its diameter.

D2-D4 also disclose a valve of the type defined in claim 1.

3. Dependent claims 2-10 do not contain any features which, in combination with the features of any claim to which they refer, meet the PCT novelty or inventive step requirements because the features of claims 2-10 are known from D1, D2, D3 or D4 or relate to simple structural measures. A person skilled in the art would readily apply these features to like effect and would arrive at a valve as per claims 2-10 without being inventive.
