**Re Item V**

**Reasoned statement with regard to novelty, inventive step or industrial applicability; citations and explanations supporting such statement**

1. Reference is made to the following document:

D1: XP002257416. Universal Mobile Telecommunications System (UMTS); Radio Resource Control (RRC) protocol specification (3GPP TS 25.331 version 3.10.0 Release 1999). ETSI TS 125 331 V3.10.0 (2002-03). Pages 87-98, 217-222.

2. It is clear from the description (for example, on page 2, lines 11-13, page 6, lines 19-21 and page 8, lines 21-27) and the drawings (fig. 3 and 4) that the following features are essential to solve the technical problem of the present invention (how to handle simultaneous RRC command procedures which change the security configuration):

- 1) rejecting the received command if both the existing and the received command include a change to the security configuration and
- 2) saving the received command to be processed once the existing command processing is completed if one of the existing or the received command do not include a change to the security configuration

Since independent claim 1 does not contain these features it does not meet the requirement following from Article 6 PCT taken in combination with Rule 6.3(b) PCT that **any independent claim must contain all the technical features essential to the definition of the invention.**

Without these essential features, the subject-matter of claim 1 does not involve an inventive step over the disclosure of document D1 (see sections 8.1.12.2.1, 8.1.12.3, 8.1.12.4a, 8.1.12.4b, 8.6.3.4 and 8.6.3.5). Moreover, in that case, dependent claims 2, 4-6 do not appear to contain any additional features which, in combination with the features of any claim to which they refer, meet the requirements of the PCT with respect to inventive step over the disclosure of document D1.

Furthermore, without these features, claim 1 does not meet the requirements of Article 6 PCT in that the matter for which protection is sought is not clearly defined. The claim attempts to define the subject-matter in terms of the result to be achieved (at the end of

claim 1, from "such..." to "sequentially") , which merely amounts to a statement of the underlying problem, without providing the technical features necessary for achieving this result.
